- The Annual Return was not accurately completed before submission for review. Box 7 of Section 1 for the current year should read £25,545 and Box 6 should read £34,629. Please ensure the correct figures are entered for 2014/15 when completing the 2015/16 Annual Return.
- Section 1, Box 11 has been submitted in pencil. The response given is 'No'.
